FREDERIC M CODE OF CONDUCT

The signatories of the membership application, whether privileged customers or registered distributors, are referred to as "members"

Article 1: FREDERIC M will indicate its approval by sending the member number. FREDERIC M will then sell the products to members in accordance with the "General sales conditions".

Article 2: Membership may be rescinded by members at any time. Rescission will take effect upon receipt of a registered letter with acknowledgement of receipt addressed to FREDERIC M. Members may only sign a new application via a new sponsor at least six months after the date of the last order and providing FREDERIC M is informed of the new application.

Article 3: Members are not mandated by the company. Members are not employed by FREDERIC M and may not commit or represent the company. Membership is accorded by FREDERIC M on a personal basis. Consequently, this membership may not be transferred (even gratuitously) to another party without the written consent of FREDERIC M. FREDERIC M may transfer this contract at any time and to any company without need to obtain the prior agreement of the member.

Article 4: The member authorises FREDERIC M to use its name, photographs and personal history in the context of professional operations and for advertising purposes. The member expressly waives any right to financial compensation in consideration of the use of this information.

Article 5: The member will exclusively sell FREDERIC M products via direct sales and in their original form and packaging. The member may not sell or display products in public locations: stores, fairs, markets or on the Internet, either on a personal site or a commercial site. The member is not authorised to store goods (use of a warehouse).

Article 6: The use of Internet and the creation of a personal site in the context of FREDERIC M business is exclusively authorised for members having achieved the minimum qualification determined by FREDERIC M. Subject to the satisfaction of this condition, an IT charter will be signed by the member with FREDERIC M. The signing of this Charter will allow the member to use the images and logos supplied by the company. FREDERIC M products may not be sold via this site under any circumstances.

Article 7: The commercial operations organised by FREDERIC M are exclusively intended to advertise brand products. Members may not use these events or the sales network to promote products of other brands in any way.

Article 8: The member acknowledges that FREDERIC M may examine the marketing plan at any time and, if necessary, revise and adapt this plan at its discretion. These modifications will apply at the time of announcement or publications.

Article 9: The FREDERIC M brand and its graphic representation are the exclusive property of FREDERIC M. Members will use the terminology recommended by FREDERIC M. Members may only use names, logos and advertising documents for the purposes of distributing FREDERIC M products. No publication of FREDERIC M may be reproduced in part or in full without the prior agreement of the company.

Article 10: Members must exercise their activities in compliance with the applicable legal texts. Generally, members must act in a polite manner and not apply any abusive pressure on customers or future members. Members will act in accordance with the legal provisions of the Consumer code by providing the customer with an order form and according to the customer the possibility to withdraw within 14 days of submitting the order. Members will not receive any advance payment before the expiry of the period of withdrawal.

Article 11: Members will comply with the general sales conditions applicable at the time of the order. Members will pay close attention to provisions on the handling of unpaid amounts, and, in particular, the suspension of orders and commission in case of an account with a negative balance. All orders submitted by a member imply the consultation and express and unlimited acceptance of the general sales conditions and the conditions of this Code of conduct.

Article 12: Should a member not comply with the code of conduct and the applicable legal provisions in the exercise of activities, FREDERIC M may automatically rescind the membership without need for legal proceedings. This rescission will lead to the termination of all deliveries and payment of commission. This rescission will take effect from receipt of the registered letter with acknowledgement of receipt or notification by a bailiff, by the member.

Article 13: The delivery and execution location corresponds to the head office of FREDERIC M assigned to the member. In case of a dispute relating to the application or interpretation of this approval, it is agreed that jurisdiction is attributed to the location of the head office of FREDERIC M assigned to the member.
